Flying Hills Pool Membership Agreement

I hereby apply for a seasonal, one-year membership at the Flying Hills Community Pool. I understand that I have the privilege of using the pools facilities during hours designated by management, in accordance with the policies and procedures now in effect that may be changed anytime during my membership.

All memberships shall be subject to the following terms and conditions:

- 1) You agree to follow all rules and regulations now in force or in the future adopted by us, including but not limited to: Rules and regulations with regard to hours of operation, use of equipment and facilities, pool use and rules, personal hygiene and attire. We reserve the right to revoke or suspend your membership, without refund if you or your guest fail to follow any rules or regulations, for reasons of nuisance, disturbance of other members moral turpitude or fraud, or if we determine that your actions may endanger yourself or other persons. If your membership is suspended, you will not receive a refund for the remainder of the season.
- 2) Members are NOT permitted to bring alcohol to the pool. Alcohol may be purchased from Divot's wait staff. Those displaying an adequate intoxicated level of behavior will be asked to leave the pool premises.
- 3) A holder of the membership shall be fully responsible to abide by and comply with all rules and regulations, which from time to time are adopted by the pool facility with respect to the reasonable and safe use and enjoyment of the facility. Failure to follow rules and regulations in any manner may lead to suspension or termination of membership at the discretion of the Pool Manager or Flying Hills Administration.
- 4) The Flying Hills Company is not responsible for lost or stolen items on or around the pool premises.
- 5) Cancellation after payment will not be accepted, and a no refund policy will be followed.
- 6) Reservation of Rights: We reserve the right at any time to close any of our facilities, alter the hours of operation, amend, add, or eliminate any program, activity, class or service at our sole discretion. Except as prevented by an act of God, war, strike, and other causes beyond our control, and subject to our rights reserved in this paragraph, we will, during the term of Member's Membership, maintain the pool facilities and supervision thereof as of the date of this contract. The facility is available subject to demand and may be crowded at peak hours or may be closed or times changed if demand fluctuates.

Release of Liability: You (member) agree to release Flying Hills Company (and our affiliates, employees, agents, representatives, successors and assigns) from any and all claims or causes of action (known and unknown) arising out of negligence. This Waiver and Release of liability includes, without limitation, injuries, which may occur as a result of (a) your wrongful doing not adhering to rules and regulations, (b) our improper maintenance of facilities, (c) our negligent instruction or supervision, and (d) you slipping or falling while in or around our facility. You acknowledge that you have carefully read this Waiver and Release and fully understand that it is a release of liability. You are waiving any right that you may have to bring a legal action to assert a claim against us for our negligence.
